1. Step up our response to climate and environmental crises	Conduct three climate and environmental risk assessments in Iraq’s most vulnerable provinces, integrating GIS, satellite data, and local knowledge.	By Dec 2025
	Integrate climate risk indicators into two national mine action clearance prioritization plans, aligning with Iraq’s NDC adaptation targets.	By Dec 2026
2. Maximize the environmental sustainability of our work	Conduct a baseline GHG emissions assessment of MILE operations and programs.	By Dec 2025
	Conduct two Webinars for Government stakeholders on Reducing GHG emissions by 20% through clean energy use, transport optimization, and waste reduction.	By Dec 2025
	Achieve a 15% reduction in Methane and black carbon emissions from targeted municipal waste streams through policy reforms, waste-to-energy initiatives, and community engagement.	By Dec 2027
3. Strengthen the capacities of our staff and local action to address climate and environmental crises	Develop and roll out a Climate & Environmental Risk Training Program for all technical and program staff, including modules on short-lived climate pollutant- (SLCP) mitigation, environmental information systems, and donor compliance.	By Q4 2025

	Deliver at least 10 targeted training workshops for government and local NGO partners on climate resilience, environmental data use, Explosive Ordinance Risk Education and Waste Management.	By Jun 2026
4. Invest in data and evidence to improve our responses	Establish a national environmental data-sharing platform with the Ministry of Environment, linking GIS, satellite imagery, and field data.	By Jun 2026
	Publish five evidence-based reports linking environmental degradation, public health, and climate change risks in Iraq.	By Dec 2026
	Ensure at least two of these reports directly inform national policy updates or NDC revisions.	By Dec 2027
5. Work collaboratively across the humanitarian system	Formalize five new partnerships with regional/international NGOs, donors, and private sector actors to advance environmental protection and climate resilience.	By Dec 2025
	Collaborate on at least two cross-border knowledge exchange activities with partners in Afghanistan and Pakistan.	By Jun 2026
	Secure USD 1 million in new funding through joint proposals and partnership initiatives.	By Dec 2027
6. Use our influence to mobilize urgent and more ambitious climate action	Reach 50,000 people through community-led climate change awareness campaigns and environmental education programs.	By Jun 2026
