SECRETARIAT UPDATES FROM COP29

COP29 Statement: Every year before the United Nations Framework Convention on Climate Change (UNFCCC) Conference of Parties (COP), the Charter has issued a statement on key challenges, priorities and opportunities at each COP. CALLS FOR CHARTER SIGNATORY ENGAGEMENT: TARGET CASE STUDIES

The **Climate and Environment Charter Secretariat** is launching a new study, with support from ADAPT Initiative: *Mainstreaming, Integrating, and Target-Setting of Climate and Environmental Considerations in Humanitarian Action.* We are currently seeking **Charter signatories who would be interested in participating in this research as a case study.** Through these case studies, the Charter Secretariat aims to illustrate how organizations are setting and progressing toward climate and environmental targets. As such, the research team are looking to connect with organisations who have already established specific **targets and are actively engaging with these through reporting, action plans, or other organisational updates**.

Participating in the study would involve completing a brief questionnaire, providing information

on your organization's target-setting strategies and climate-related work where such documentation exists, and participating in approximately three key informant interviews with various members of your organizations. We anticipate these interviews being conducted in 2024, or January 2025, depending on availability. <u>Handbook on Early warning systems and early action in fragile, conflict-affected and violent contexts: Addressing growing climate and disaster risks</u>, UNDRR, 21 October 2024

The Handbook on Early Warning Systems (EWS) and Early Action in Fragile, Conflict, and Violent (FCV) Contexts aims to bolster climate action in the world's most vulnerable regions. This Handbook seeks to drive a comprehensive approach to promote increased investment in EWS in FCV contexts and to support local-level action by helping countries and vulnerable communities better anticipate disasters, protect vulnerable populations, and build long-term resilience to a rapidly changing climate.

<u>Effective emergency preparedness for flooding and drought: A guide for Cities</u>, C40 Cities Climate Leadership Group, 2024

This guide outlines five key components for effective emergency preparedness. It sets out practical steps that cities can take to help protect vulnerable communities from <u>flooding</u> and <u>drought</u> and shares relevant case studies from cities around the world. At the end of the guide, a self-assessment checklist helps cities to evaluate their current progress and identify areas for improvement and further action.

For example, the <u>Framework for Greening Humanitarian Action</u> in the Pacific, offers an operational and contextualised framework that provides local, national, regional and international humanitarian practitioners, policymakers and donors with a practical approach and actions for strengthening greener humanitarian action. The framework can be adapted and scaled to meet the needs of different actors at different stages of their greening journey and can be used as a guide to inform development of contextualised tools in other regions. Review, October 2024 IMC has advanced various programmatic interventions that tackle a variety of issues at the intersection of health and climate, including health, nutrition, food security and livelihoods (FSL), and water, sanitation and hygiene (WASH).
