Together with Community World Service Asia and ADAPT Initiative, the Charter Secretariat held a workshop on *Mainstreaming Climate and Environmental Considerations in Humanitarian Action* on the sidelines of the Regional Humanitarian Partnership Week in Bangkok on 13 December 2024. The workshop brought together thirty signatories of the Charter ranging from local, national, regional and international NGOs and Red Cross/Red Crescent movement working across the Asia-Pacific region to share experiences, challenges, and strategies for integrating climate and environment commitments into their humanitarian programming. FUNDING OPPORTUNITIES

USAID/BHA Climate Smart and Disaster Ready APS Round 2, January 31, 2025 The Bureau for Humanitarian Assistance announced the launch of <u>Round 2</u> of the Climate Smart and Disaster Ready Annual Program Statement (APS). The goal of the Climate Smart and Disaster Ready APS is to implement innovative and applicable adaptation solutions in communities at greatest risk to climate related disasters, in current and foreseeable humanitarian settings. Round 2 focuses on soliciting concepts across four Technical Priority Areas:

- 1. Support integrated watershed and landscape-scale natural resource management (NRM) approaches.
- 2. Scale locally-led Nature-based Solutions (NbS) activities.
- Strengthen capacity of multi-hazard early warning systems (EWS) and provision of climate information services (CIS).
 Prioritize capacity strengthening for leastly lad disaster and elimete risk reduction including.
- 4. Prioritize capacity strengthening for locally-led disaster and climate risk reduction including anticipatory action (AA) approaches.

Ocean Community Empowerment and Nature (OCEAN) Grants Programme is now Open, February 17, 2025

OCEAN is a new competitive grants scheme that will support innovative proposals from local coastal communities and organisations that aim to deliver marine protection and reduce poverty worldwide. It is part of the UK's Blue Planet Fund - a £500 million programme supporting developing countries to protect the marine environment and reduce poverty - and aims to support the people and communities most impacted by declining ocean health and climate change through funding local solutions to local problems. The UNEP/OCHA Joint Environment Unit (JEU) is pleased to announce the next Environment in Humanitarian Action Network (EHAN) event will be held as part of the <u>Humanitarian Networks</u> and <u>Partnerships Week (HNPW)</u>. The meeting will be **hybrid**, allowing for both in-person and virtual participation. The EHAN session will focus on three critical themes:

- Environment and Conflict Nexus
- Localisation and Accountability in EHA

Call for Case Studies, Loss and Damage Collaboration (L&DC), 28 March 2025

Ahead of the fifth meeting of the Board (B5) of the <u>Fund for Responding to Loss and Damage</u> (FRLD) which will take place on the 8-10 of April 2025 in Bridge Town, Barbados, L&DC are seeking case studies on access to climate, development or humanitarian finance for communities, Indigenous Peoples, local Civil Society Organisations (CSOs) and organisations representing marginalised groups. The L&DC welcome stand alone published case studies, case studies published in briefs, unpublished case studies (text or linked documents), video/photo essay case studies.

POLICY AND REPORTS

Prioritising Children's Health Amidst the Climate Crisis, Save the Children International, December 2024 (English, French, Spanish and Arabic)

Climate change severely impacts children's health, especially in low- and middle-income countries (LMICs), increasing risks of diseases, malnutrition, and mental health issues while threatening access to clean water, sanitation, and healthcare. Vulnerable groups, including impoverished, displaced, and children with disabilities, face the greatest challenges.

A bold response is essential to safeguard the health and future of 2.4 billion children globally. While this brief focuses on adaptation and resilience, it underscores the importance of mitigation to reduce long-term risks and protect future generations. This policy brief calls for urgent, multisectoral action, including:

- Governments prioritizing climate-resilient, child-sensitive services and closing the adaptation funding gap.
- Global health organizations, multilateral banks, and private sectors scaling up climatesensitive financing and support for climate-resilient and low-carbon health systems.
- All stakeholders to ensure meaningful participation of children and communities in climate-health decision-making processes.

<u>A fair and equitable decarbonisation target for an international NGO</u>, Group URD, December 2024

Since 2020, in response to the climate emergency, a growing number of NGOs have committed themselves to reducing their greenhouse gas emissions. Like other organisations, the NGO that commissioned this report committed itself to reduce its greenhouse gas emissions by 50% by 2030, with 50% being an absolute value by comparison with 2019. Emissions are to be accounted for as fully as possible. Is this target fair, however? The aim of this report is to analyse this NGO's decarbonisation targets, as well as the monitoring and review process, highlighting some of the pitfalls of carbon accounting and reviewing some of the foundations of environmental ethics and climate justice. Finally, the report puts forward proposals for a fair decarbonisation target.

Advancing Action on Land Degradation, Desertification and Drought

The President of the <u>sixteenth meeting of the Conference of the Parties (COP16)</u> to the **United Nations Convention to Combat Desertification (UNCCD)** closed on 14 December 2024, as the largest and most inclusive UNCCD COP to date, with more than 20,000 participants in over 600 events. At COP16, Parties adopted 39 decisions, including:

- Creation of a Caucus for Indigenous Peoples and a Caucus for Local Communities.
 Continuation of the Convention's Science-Policy Interface to strengthen science-based decision-making.
- Mobilization of private sector engagement under the <u>Business4Land</u> initiative.
- A prototype launch of the International Drought Resilience Observatory, the first global Aldriven platform to help countries assess and enhance their capacity to cope with harsher droughts.
- Decisions on the budget, the decision on the midterm evaluation of the Strategic
- Framework, and the procedural decision on drought were also taken.
- Parties adopted the <u>Riyadh Political Declaration</u>.
 Over USD 12 billion were pledged to tackle desertification.
- Over USD 12 billion were pledged to tackle desertification, land degradation and drought around the world, especially in the most vulnerable countries.
- Despite notable efforts, Parties did not agree to begin talks on a new drought framework or legally binding protocol. A procedural decision was adopted to continue discussions based on the progress made at COP 16, with a view to adopting a decision at COP 17, in Mongolia, in 2026
