In our 4th Letter to Parties, we **introduced the structure of the Action Agenda**.

Today, we'll focus on how we'll execute.

The Action Agenda is designed to significantly contribute to the Brazilian Presidency's three strategic priorities:

- Reinforce multilateralism and the climate regime under the UNFCCC;
- Connect global climate action to the real lives of people;
- Accelerate implementation of the Paris Agreement by stimulating action and structural shifts across capable institutions.

To support these priorities, the Action Agenda is built

- **to**:Prioritize implementation of past commitments, drawing from the first Global Stocktake (GST-1) findings from COP28, the first evaluation of the Paris Agreement;
- Map initiatives launched in previous COP Action Agendas, to identify progress, gaps, and opportunities for alignment;
- Establish a monitoring and evaluation framework to track progress, avoid duplication, and amplify the efforts of those driving implementation.

Climate security references in Developing States' NAPs & NDCs


NAPs: country-led strategies that outline how nations will prepare for and respond to the impacts of climate change.

NDCs: each country's climate action plan that sets targets for reducing emissions and adapting to climate change.


Out of **148 Developing countries**:

- 30% with 1 proxy, 24% with 2, and 26% with 3
- Food insecurity (71%), displacement (51%), and conflict (36%)
- Political share: 71% for LDCs, 50% for SIDS, much less for non-SIDS/LDC
- Regional share: Africa & Latin America leading (60-66%) v. Asia-Pacific (38%) & Eastern Europe (22%)

Why displacement matters for Loss & Damage?

- Displacement as an indicator of L&D Its occurrence signals when the severity of disaster impacts or level of risks exceed people's ability to cope with
- 2. Displacement as a form of L&D People endure adverse outcomes directly stemming from displacement (limited access to services and financial resources, psychological distress, loss of agency, etc)
- Displacement as a driver of L&D Cascading impacts for displaced people and receiving communities (increase in food and housing market prices, interrupted education, inability to pay taxes, etc)
- → All these costs amount to billions but are often hidden/underestimated



Inclusion of displacement into the L&D Agenda

Year	COP / Location	Key Document	Summary
2010	COP16 (Cancun)	Cancun Adaptation Framework	First explicit mention of climate-related displacement, migration, and relocation under adaptation measures.
2012	COP18 (Doha)	Doha Decision	Links human mobility to the emerging loss and damage agenda.
2013	COP19 (Warsaw)	Warsaw International Mechanism (WIM)	Establishes an institutional framework; includes displacement within its scope.
2015	COP21 (Paris)	Paris Agreement & Decision 1/CP.21	Creates the Task Force on Displacement (TFD) to address climate-related displacement.
2019	COP25 (Madrid)	Santiago Network on Loss & Damage	Launches technical assistance mechanism to support vulnerable states facing climate impacts.
2023	COP28 (Dubai)	Loss & Damage Fund & Global Stocktake	Fund becomes operational with displacement explicitly eligible for financing; global progress report acknowledges displaced populations.



COP30 - Priorities and key messages

- 1. All mitigation measures must integrate the objective of averting and minimising displacement Prohibit forced eviction and land dispossession caused by mitigation projects, ensure FPIC
- 2. Just Transition measures must include the most vulnerable decent work for all, protect workers affected by mitigation and adaptation measures, skill-building
- 3. All adaptation work programmes must integrate HM considerations GGA indicators that include HM dimensions and disaggregate data by mobility status, integrate HM into NAPs
- 4. Displacement must be embedded as a core element of L&D opp. of the WIM Third Review, TFD, resource the SNLD, integrate displacement into national reporting (BTRs, NDCs)
- 5. Climate finance must meet the scale of the challenge direct, rapid and accessible grant-based funding for migrants, displaced people, refugees and receiving communities, Parties must meet their obligations to provide climate finance
- 6. Displaced people must meaningfully participate in decision-making and project implementation language accessibility, visa, access modalities



Key COP30 agenda items relevant to L&D

- Third Review of the WIM opportunity to increase collaboration, avoid duplication, deliver a yearly/biannual State of L&D report, request guidelines on including L&D in NDCs
- 2. Joint report of the WIM ExCom and Santiago Network opportunity for countries to ask the SNLD to increase the number of local and regional experts in its membership, increase outreach to countries and communities so they know what support is available from the SNLD, deliver support on time and remind rich countries to resource the SNLD with sufficient funding
- 3. Report of the FRLD opportunity to ask the Fund to provide sufficient resources (400 billions USD a year), community access to small grants, increased Observers' participation, remind rich countries to fill the Fund
- 4. Launch of the call for proposals for the start-up phase of the FRLD*(Barbados Implementation Modalities) Countries will have 6 months to apply for between 5-20 million USD*

- Objectives:
- (1) develop & implement a roadmap for climate and environment action,
- (2) contribute to joint collective advocacy, in particular coordinated engagement in UNFCCC processes
- Membership: IASC members & relevant non-IASC members (e.g. UNDRR, WMO etc.)



Top Line Messages for COP 30

- Leave no-one behind and prioritize the most vulnerable and impacted, including women and girls and people living in fragile and conflict affected contexts
- Ensure meaningful, effective, and safe participation for those on the frontlines of the climate crisis.....Currently, the high costs of attending UNFCCC COP 30 are limiting participation and in turn reducing the diversity of voices represented. We urge further discussion about ways to reform the COP process to ensure fully equal and meaningful inclusion of affected and at-risk communities



Top Line Messages for COP 30

- Scale locally and nationally specific adaptation actions: Global Goal on Adaptation (GGA) indicators are due to be agreed at COP 30······
- Deliver on resources for loss and damage for those on the frontline of the climate crisis: Member States should consider setting a target for the delivery of FRLD resources to the local level and in particular to fragile and conflict-affected contexts. Community participation and locally led climate action should be integrated as part of "country-led and country-owned approaches" to addressing loss and damage.
- Boost Early Warning Systems and Anticipatory Action
- Call for commitments to ensure we get back on track to 1.5°C

As we prepare for the 30th Conference of the Parties (COP30) in Belém, Brazil, the nearly 500 signatories to the Climate and Environment Charter for Humanitarian Organizations reaffirm our commitment to address the escalating impacts of climate change on vulnerable communities – especially those in conflict, fragile, and protracted crisis settings. STATEMENT BY SIGNATORIES OF THE CLIMATE AND ENVIRONMENT CHARTER FOR HUMANITARIAN ORGANIZATIONS AHEAD OF COP30

As we prepare for the <u>30th Conference of the Parties</u> (COP30) in Belém, Brazil, the nearly <u>500 signatories</u> to the <u>Climate and Environment Charter for Humanitarian Organizations</u> reaffirm our commitment to address the escalating impacts of climate change on vulnerable communities – especially those in conflict, fragile, and protracted crisis settings.

Intensifying floods, cyclones, droughts, and extreme heatwaves – as well as slow-onset climate events – are compounding insecurity and driving displacement, food and water shortages, and loss of livelihoods around the world. These impacts are disproportionately affecting women, children and youth, older people, people with disabilities, Indigenous peoples, LGBTQI+ individuals, migrants, refugees, and other marginalized groups. With many pushed beyond their capacity to recover, leaving many in desperate situations, including being displaced multiple times, and for some, with options of no-return - the climate crisis is also a humanitarian crisis.

We are encouraged to see that there are opportunities through the One Global Climate Action Agenda, (especially under 3, 4, 5 and cross-cutting pillars), to mobilize voluntary climate action from state and non-state actors to address the impacts of climate change on most vulnerable communities. However, despite 5 years of progress in linking relief, recovery, and peace in COP discussions, the humanitarian impacts of climate change, including loss and damage, lack a dedicated thematic focus in this year's COP agenda.

This comes at a time when the humanitarian sector faces profound challenges – caused by sudden reductions in funding, rising needs and compounding crises. In this new reality, people in need of humanitarian assistance – including many communities most affected by climate change – face reduced funding and limited resources to enable their participation in critical advocacy discussions.

We must ensure that impacted communities are included in decision-making processes at COP30 and that climate policies and financing mechanisms reflect and prioritise their needs. As reflected in the 2025 Advocacy Priorities of Charter Signatories, we call on all stakeholders to:1

- Keep Frontlines First by centering perspectives of communities most impacted by the crisis, as well as vulnerable and conflict-affected communities, in COP30 planning, outcomes, and implementation.
- Integrate humanitarian and conflict-sensitive approaches across Nationally Determined Contributions (NDCs), National Adaptation Plans (NAPs), and relevant frameworks to ensure inclusive, peace-positive climate action.
- Redouble efforts to avert and minimize the impacts of climate change and get back on track to 1.5C by including ambitious commitments in Nationally Determined Contributions (NDCs) to drastically reduce greenhouse gas emissions and advancing strong mitigation actions, including ending fossil fuel expansion and foster a just economic transition
- Prioritize, scale and simplify access to adaptation and Loss and Damage finance
 for frontline communities, including those in conflict-affected contexts, through
 flexible, risk-tolerant mechanisms available for crisis-affected communities and diverse
 local and national actors. This requires ensuring these communities and actors are part
 of the decision making and that COP30 delivers a new, equitable adaptation finance
 commitment prioritizing the most vulnerable.
- Rapidly scale-up locally led, gender responsive early warning and anticipatory
 action systems, ensuring that no one especially those in fragile and conflict-affected
 settings is left behind.


Responding effectively to the climate crises will require us to strengthen cooperation between climate, humanitarian, development, and peace sectors. The UNFCCC COPs are a key opportunity to advance this agenda. The humanitarian sector is already acting to address this existential challenge, and we call for continued engagement of our partners across all sectors to deliver on our shared commitments.

At COP30, Parties are expected to advance implementation pathways for the Paris Agreement and operationalize funding mechanisms under the Global Goal on Adaptation and Loss and Damage Fund. Yet, populations living in conflict, fragility, and crisis are often excluded from these processes. COP30 is marked by a lack of a dedicated conflict and peace-day, a departure from the past five years of increasing attention on humanitarian perspectives within the COP world. Humanitarian actors who work directly with these communities, can help ensure that climate action genuinely reflects the priorities of those most affected by climate and environmental shocks.	The 2025 Advocacy Priorities call for an Inclusive Climate Response that prioritizes needs and capacities of the most vulnerable populations, leveraging the humanitarian sector's relationships with these communities within national and international fora such as COP30. The 2025 Advocacy Priorities call for highlighting the Humanitarian Role and Expertise in Climate Response, sharing best practices and community-knowledge from the humanitarian sector in its response to climate impacts.

 in connecting emergency response, loss and damage, and long-term adaptation
 through sectoral expertise and community-led knowledge.
- Advocate for mechanisms that enable affected communities to co-design adaptation and mitigation measures
- Advance peace-positive and inclusive climate action that addresses the human and environmental costs of war and the intersecting vulnerabilities of women, youth, older people, people with disabilities, Indigenous peoples, LGBTQI+ individuals, migrants, refugees, and displaced and marginalized groups.
